Section 5. Firefighting measures

Specific hazards arising from the chemical

: Flammable liquid and vapour. In a fire or if heated, a pressure increase will occur and the container may burst, with the risk of a subsequent explosion. Section 7. Handling and storage

Precautions for safe handling

Protective measures

Appropriate engineering controls
